The article is not restricted to IMO IMDG Code according to special provision 188.



Its package has passed the 1.2m drop test, test report number: STRD1803001S-2.
3	除安装在设备中外,电芯和电池须装在完全将其封闭的内包装内。电芯或电池须加以防护以免发生短路。这包括防止在同一包装内与可能导致短路的导电材料接触。内包装须装在符合 IMDG CODE 第 4.1.1.1、4.1.1.2 和 4.1.1.5 段规定的坚实的外包装内。 Cells and batteries, except when installed in equipment, shall be packed in inner packagings that completely enclose the cell or battery. Cells and batteries shall be protected so as to prevent short circuits. This includes protection against contact with conductive materials within the same packaging that could lead to a short circuit. The inner packagings shall be packed in strong outer packagings which conform to the provisions of 4.1.1.1, 4.1.1.2, and 4.1.1.5.
4	安装在设备中的电芯和电池须加以保护以避免损坏和短路,该设备须配备有效的防止意外激活装置。如果电池安装在设备内,该设备须被包装在坚实的外包装内,该外包装由具有足够强度的材料建造并且设计与其容量的拟定用途相适应,除非内含这些电池的设备能够提供等效的保护。  Cells and batteries when installed in equipment shall be protected from damage and short circuit, and the equipment shall be equipped with an effective means of preventing accidental activation. When batteries are installed in equipment, the equipment shall be packed in strong outer packagings constructed of suitable material of adequate strength and design in relation to the packaging's capacity and its intended use unless the battery is afforded equivalent protection by the equipment in which it is contained.
