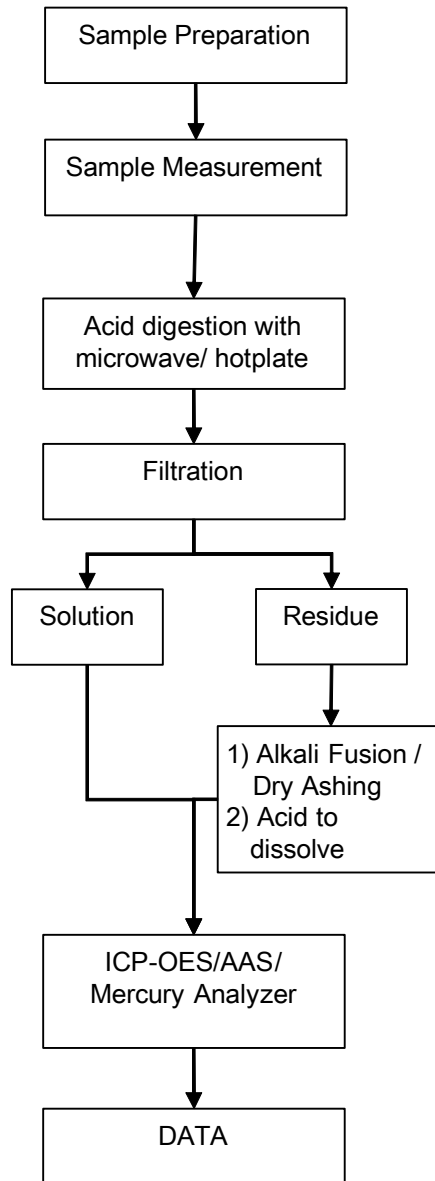

Battery Testing Flow Chart

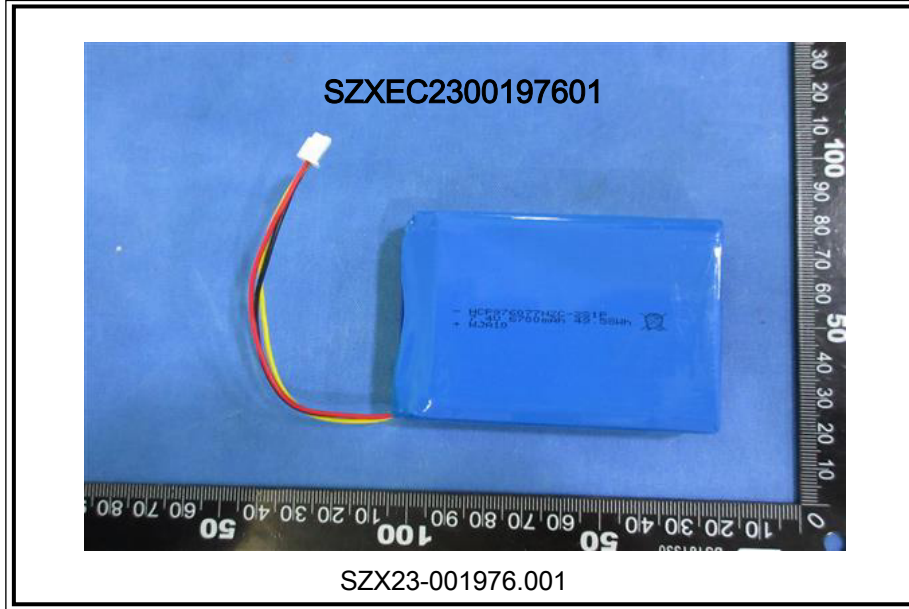
